OMOV for the NPF now!

Ann Black, NEC member writes:

"One-member-one-vote (OMOV) is a cornerstone of the modern Labour party. For the national policy forum it would give a voice to the 20% of constituencies who do not send delegates to conference, and create a more direct relationship between members and their representatives. When I visit local parties, most cannot name the NPF members who have spoken on their behalf for the last twelve years.

The change would not take the party back to the bad old days of internal strife, as some have suggested. That has not happened on the NEC, where I and my colleagues are elected by one-member-one-vote, nor in Scotland, where their successful policy forum is already elected through an all-member ballot. Indeed, one-member-one-vote was introduced in the 1990s to increase the diversity of political views, and to prevent dominance by any faction. That principle still holds good.

As always there will be arguments for and against, and delegates will have the final say. I hope that before the vote, they will confer with their local parties, and act in accordance with their wishes."

"The range of views and the vitality of the debate that takes place in CLPs is clear in the submissions made to the NPF. Unfortunately this diversity of views is not reflected at NPF meetings.

At the NPF it is clear that one perspective dominates. As a result, many issues supported by a significant proportion of the membership, (e.g. support for the fourth option, the abolition of selection in schools and opposition to PFI) make little progress. If the NPF is to have credibility and more dynamism, it needs to be more representative of the membership".

Leeds strikers need your support

600 GMB and Unison members employed by the Lib Dem/Tory council in Leeds in the cleaning department are on their fourth week of strike over plans to cut their average pay by £6,000 a year from £18,000 down to below £13,000 to achieve equal pay. Yet More Shenanigans

Reports are coming into Campaign Briefing thick and fast of what appears to be illegitimate interference in our internal democracy. So far we have heard strong rumours about officials in the South East, South West and Yorkshire regions taking selected CLP delegates out of the hall to meet the NPF Chair Pat McFadden. It is clear from the reports that Pat's pleading against OMOV is becoming increasingly desperate. Pat is fully entitled to lobby delegates but he is not entitled to ask party staff, who are supposed to be impartial, to do his dirty work for him.

It has also been reported that regional staff in the South East were telling delegates who to vote for in Monday's CAC election.

Other rule changes today

2.B5 Hendon and Hyndburn CLPs propose a Charter of Members' rights ensuring transparency in the policy-making process, right to participation in party governance and the right to freedom of expression. SUPPORT

4.C.1.A.i.c Beverley and Holderness CLP propose to increase the CLP seats on the NEC with a constituency seat from Scotland and one from Wales. This will increase the CLP seats to 8. Wales and Scotland have their own government and should have their own CLP reps on the NEC. **SUPPORT**
